Subject of the contract

This contract refers to the photo shooting on __. __. 2019 and is valid for approx. __ hours.
A possible pre-meeting is not part of the actual photo shoot.

This contract does not create an employment relationship.

The model undertakes to be available for the entire length of the photo shoot. The model is obliged to the photographer for a neat appearance.

The model confirms that (s)he is 18 years or older at the time of making the pictures. (S)he is entitled to bring a person of their trust to a possible pre-meeting and photo shoot. This person must not interfere with the course of the recordings.

Shooting fee

The model receives as a fee

- _____ Euro for the entire duration of the shooting.
- all images of the shoot processed by the photographer within 4 weeks. The photos are made available for download to the model in digital format JPG. All claims and rights of the model are compensated with the fee. According to the results, the photographer decides which and how many images from the respective photo series are processed by him. Processing is not mandatory.
For the model or third parties, it is **not** permitted to edit the images.

Copyright and rights of use

The transfer of the rights of use extends to all currently known uses and also includes self-promotion, reproduction, distribution, digitisation, exhibition, demonstration, broadcast, public access and communication to the public by image/sound/disks. The recordings may therefore be used both digitally and analogously in all relevant media (e.g. online use of any kind, any print use, TV, cinema, theatre, video grams (CD, DVD, etc.), interactive and multimedia use, etc.) and in databases, including to the extent that they are accessible online.

The photos may **not** be published in media with pornographic, similarly frivolous content or questionable contexts.

The Photographer...

...is entitled to irrevocably unrestricted, content, time and local unlimited use, storage and exploitation of the photos,

for private purposes, as well as for non-commercial purposes (self-promotion e.g. Internet, Sedcard).

as well as for commercial purposes (sale of images).

The photographs may be edited, alienated or redesigned by the photographer (e.g. montage, combination with images, texts or graphics, photo-technical alienation, colouring) as long as it does not counteract the image situation. The photographer assures that changes to the image serve to enhance the quality.

When published by the photographer, the model is allowed to be named

on social media by linking to the model's profile,

otherwise in the form „_____“.

The Model...

... is entitled to irrevocably unrestricted, content, time and local unlimited use, storage and exploitation of the images made available for download,

for private purposes, as well as for non-commercial purposes (self-promotion e.g. Internet, Sedcard).

as well as for commercial purposes (sale of images).

The images provided may **not** be edited or redesigned by the model. If there is a watermark on the images, it must **not** be removed.

When published by the model, the naming of the photographer is mandatory

- on social media by linking to the profile of the photographer,
- otherwise in the form „**Photo: [o] Siegfried Steins (www.sigityv.de)**“.

Other

Side agreements are not made. Amendments and additions to this Agreement require the text form to be effective.

This contract is subject exclusively to the law of the Federal Republic of Germany to the exclusion of conflict of laws. In the event that the model is not domiciled in the Federal Republic of Germany, the place of jurisdiction shall be the registered office of the photographer.

With his signature, the model confirms the receipt of a signed contract copy.

Severability clause

In the case, individual provisions of this contract are ineffective or unenforceable or become ineffective or unenforceable after the conclusion of the contract, the validity of the contract shall remain unaffected in the remainder of the contract.

Data Privacy

With the signature, the model consents to the storage of the specified data as well as indirect data, which can be produced by reference to the photos. The data protection rights in accordance with the European GDPR apply. The model has understood and accepts the data protection regulations in accordance with the appendix.
